

Legal Requirements

- The license to operate the health facility shall be considered expired in any of the following cases:
 - The health facility remains closed for more than six consecutive months without an excuse acceptable to the Health Licensing Authority.
 - The health facility fails to commence it's operation and activity for more than six months as of the licensing date without an excuse acceptable to the Health Licensing Authority.
 - Non-renewal of license within six months from its expiry date
 - Closure of health facility upon its owner request
 - The health facility is finally closed by disciplinary decision
 - The health facility is finally closed by judicial decision
- Any facility or individual shall be prohibited from practicing any activity in relation to health sector in the Emirates, without obtaining a license from DoH.
- Practicing of profession in the country is prohibited without obtaining liability insurance against medical error from a licensed insurance company in the country.
- Owners of facilities shall undertake to insure their practitioners against the following:
 - Liability for medical errors, the facility owner shall bear all insurance premiums.
 - Profession risks resulting from practicing the profession or because of it. In this
 case, owners of facilities shall bear the full cost of insurance premium for their
 employees.
- The license renewal application may be submitted at least one month before it's expiry date.
- In case of failure to renew the license during a month from its expiry date, the facility shall pay:
 - Renewal delay fine in the amount of 25% of license fees, for each month of delay (maximum 6 months)
 - Fine in the amount of 10,000 AED (Ten Thousand) monthly for each month, in case the facility license in not renewed for the health insurance scheme.

- إغلاق المنشأة نهائياً بحكم قضائي
- يحظر على أي منشأة أو فرد مزاولة أي عمل من الأعمال الخاصة بالقطاع الصحي في الإمارة دون الحصول على ترخيص بذلك من الدائرة
- يحُظرُ مز اُوّلة المهنةُ بالدولة دُونَ التَّأمين ضدَّ المسؤُولية الطبية لدى إحدى شركات التأمين المرخص لما بالدولة
 - يلتزم صاحب المنشأة بالتأمين على مزاولي المهن الطبية العاملين لديه عن الآتي :
- المسؤولية المدنية عن الأخطاء الطبية و يتحمل صاحب المنشأة كامل أقساط التأمين
- التأمين صد المخاطر الناجمة عن ممارسة المهنة أو بسببها و يتحمل صاحب المنشأة
 كامل قسط التأمين على العاملين لديه في هذه الحالة
 - يسمح بتقديم معاملة تجديد الترخيص قبل شهر عُلى الأقل من انتهائه
 - في حال عدم تجديد الترخيص خلال شهر من تاريخ انتهاء الترخيص يترتب على المنشأة الأتى:
